Re: American Rescue Plan Funds – Performance Oversight Council Bill 21-0121 Monthly Report

Background

This memorandum accompanies the City of Baltimore Mayor's Office of Recovery Program's submission of its monthly report to the City Council on spending and performance related to American Rescue Plan Act (ARPA) funding. Specifically, Council Bill 21-0121 § 49-2(B) prescribes the elements of legislatively required reporting, which stipulates that monthly reports should:

- 1) Provide data and metrics regarding how the funds have:
 - I. Increased the effectiveness of city government services;
 - II. Broadened the reach of city government services;
 - III. Made city government services more efficient;
 - IV. Made city government services more sustainable
- 2) Identify key performance indicators, benchmarks, and targets related to:
 - I. Equity, as defined in Article 1, § 39-1 of the Baltimore City Code;
 - II. Population Growth;
 - III. Labor and Employment;
 - IV. Economic Growth, especially the growth of minority and women-owned businesses; and,
 - V. Community Benefit

Commitments and Expenditures

At the end of July 2022, the Mayor's Office of Recovery Programs has committed \$521.4 million in ARPA funds to City agencies, quasi-governmental organizations, and nonprofits to advance priority initiatives for the benefit of Baltimore City residents.

Since the last report to City Council, total commitments have increased by \$31,735,000:

- Department of Planning will receive \$14,660,000 for Clean Corps to create a cleaner and healthier Baltimore;
- Department of General Services will receive \$6,450,000 for Baltimore Police Department Fleet Resources;
- Housing Authority of Baltimore City will receive an additional \$4,000,000 for Perkins Somerset Oldtown Infrastructure; and
- Nonprofits will receive \$6,625,000 through a second round of nonprofit awards.

As of June 2022, \$42.7 million dollars have been spent for ARPA-funded projects. Expenditure data for July 2022 have not yet been finalized. On August 8, 2022, the City of Baltimore successfully completed Phase II of Workday implementation, transitioning all financial transactions from multiple legacy systems into one modern, cloud-based application. As expected after a large-scale technology implementation, the Recovery Office and other City agencies are working to review and validate data in Workday. Once this review has been completed and any notable questions or discrepancies addressed, the Recovery Office will resume submission of monthly and cumulative expenditure data to City Council.

The fiscal administrators of the Economic Recovery Fund (ERF), quasi-governmental organizations, maintain accounting systems that are separate from the City's Workday financial system. Each month, they must report to the Recovery Office on their spend-down of the portion of the Fund that they are administering. (The City disburses funding to the fiscal administrator according to an invoice schedule and then the fiscal administrator awards the funding to beneficiaries or subrecipients, the final step to fully expend the funds and meet the Fund's objectives.) The ERF expenditures, shown in the Appendix, have been updated to include data through July 2022.

Performance Measures and Metrics

The Recovery Office presented performance data for more than 30 measures in the annual Recovery Plan Performance Report submitted to the United States Department of Treasury at the end of July 2022. See Section 6, "Performance Report," in **the report** posted on the Recovery Office website.

As previously noted, many agencies are still fully designing and implementing programs, therefore data are limited. Additional data on performance measures will be included in Council reports as programs are further implemented and data becomes available. The Recovery Office anticipates including some targets and benchmarks for agency performance during the FY23 period of performance. In the interim, the report includes narrative information on agency accomplishments to date.

Equity

The annual Recovery Plan Performance Report includes an 8-page narrative detailing the Recovery Office's progress to-date in advancing equity through ARPA funds. The narrative describes:

- Goals: The historically underserved, marginalized, or adversely affected groups in Baltimore City that ARPA funds will benefit;
- Awareness: How residents can learn about the programs and services funded by ARPA;
- Access and Distribution: How the Recovery Office and City agencies are actively promoting equitable access and distribution of ARPA resources; and
- Outcomes: The ability of the Recovery Office to review performance data by demographic characteristics like race, income, and neighborhood and how intended program outcomes will address inequities.

In addition to developing this extensive narrative on equity efforts, the Recovery Office is working with university partners and others in the coming months to establish equity-related targets based on best practices and available baseline data.

Population, Labor & Employment Growth

Council legislation requires key performance indicators, benchmarks, and targets related to population growth. No data source exists that would demonstrate population growth on a monthly basis. In addition, some ARPA funding may be used for programs and initiatives that could result in population growth. However, such instances would be anecdotal in nature, and cannot be positively correlated to ARPA.

The Mayor's Office of Recovery Programs has awarded ARPA funding for significant investments into small businesses, and non-profits with a prioritization on minority and womenled organizations. As previously noted, data are limited as programs are being implemented. The results of efforts to date are included in the Economic Recovery Fund portion of the report.

The Mayor's Office of Recovery Programs continues to make significant progress in the awarding of ARPA funds, the monitoring of agency and organization's progress, and in the accountability and transparency in the use of these funds. Commitments

Table 1 lists ARPA commitments through the month of July 2022, totaling \$521,428,588 with \$31,735,000 in commitments added in the month. Expenditure data for July 2022 will be presented in a future monthly report, as indicated in the cover memorandum for this report.

ARPA Expenditures in Previous Months

The Recovery Office has increased ARPA-related expenditures every month since its formation, with the largest monthly increases in expenditures between December 2021 and June 2022 (see figure below). About 7% of Baltimore's total ARPA allocation was expended by the end of June 2022, while about 81% of the allocation is currently committed.

Recovery Office Accomplishments

Since the last report, the Mayor's Office of Recovery Programs announced its second round of funding commitments to 8 nonprofit organizations, totaling \$6.6 million:

- B360 will receive \$1,250,000 to help provide workforce training and youth STEM education programming in Baltimore City.
- Baltimore Safe Haven will receive \$500,000 to provide transitional housing case management, and guidance to reduce homelessness and risk factors contributing to homelessness.
- Bethel Outreach will receive \$1,250,000 to provide Upton residents with essential resources and services such as food, shelter, healthcare, employment, and completion of the wellness center.
- Chesapeake Shakespeare Company will receive \$275,000 to address education disparities by offering Baltimore City school students a theater experience free-of-charge to its Student Matinee Program.
- Downtown Partnership will receive \$1,600,000 to revitalize Downtown Baltimore's historic retail core, which was significantly impacted by the COVID-19 pandemic.
- Greater Baltimore Urban League will receive \$1,000,000 to provide counseling, case management, skills training, and certifications for 120 residents returning from incarceration.
- North East Housing Initiative will receive \$300,000 to provide low-income residents with housing counseling, tutoring programs, support services, and job readiness training.
- Soccer Without Borders will receive \$450,000 for Latinx youth in Southeast Baltimore who have struggled during COVID-19, using soccer as an entry point to help students advance academically.

Subawardee Accomplishments

Economic Recovery Fund

A total of 598 grants, totaling \$11,218,321 have been awarded from Economic Recovery Fund fiscal agents to beneficiaries to date, including nonprofits and small businesses (the full list of organizations is in the appendix). The map below indicates the location of all organizations funded in July and prior. Please note, some nonprofit organizations funded by BCF used their headquarters address on applications for funding. Though the location where services are rendered may not be specifically depicted in the map, sub-awardees provide services to a wide variety of neighborhoods across the City.

Baltimore Civic Fund (BCF) Economic Recovery Assistance

For the 2021 Nonprofit Relief Fund recipients, the 6-month survey period closed on July 15th, 2022. Baltimore Civic Fund (BCF) collected and aggregated responses from 97 of the 231 recipients. BCF shared a summary and a detailed table of responses with the Recovery Office on July 28th. Of note, 61% of respondents had received no other government support. 63% of recipient organizations responding to the survey had female leadership and 42% of respondents had Black leadership.

For the 2022 Nonprofit Relief Fund, BCF announced 120 awardees. Each awardee was sent a grant agreement. All except one, which declined the award, accepted and signed the grant agreement. The 119 grantees will be required to submit a final report and supporting documentation for proof of payment to be reimbursed. Final reports will be received on a rolling basis through September 16, 2022. BCF received and approved the first four final reports; payments will be made in August.

Baltimore Development Corporation (BDC) Economic Recovery Assistance

BDC issued grant payments to two new recipients, totaling \$13,500 in July 2022. In addition, BDC made 26 second payments to previously awarded business, totaling \$216,536.

BDC and the Recovery Office are preparing to amend the subgrant agreement for this project to reduce the maximum award amount to \$25,000, to permit BDC to award Child Day Care service providers, and to permit businesses that were established prior to January 1, 2021 to apply for funds. BDC proposed this so that they could expand the number of awardees who have not

received prior funding in their next round, as well as to include startup businesses that began in the midst of the public health emergency. Additionally, BDC received a number of applications from child day care service providers, and since Family League fully expended their award funds, BDC is interested in funding these small businesses and providing them technical assistance.

Visit Baltimore Economic Recovery Assistance

Visit Baltimore has completely expended its \$2.5 million grant award. Thirty-seven hotels received a total of \$2,350,002 dollars, and Visit Baltimore reported \$149,998 in administrative expenses. The average award was \$63,513.57. No additional funding will be disbursed.

Baltimore Office of Promotion and the Arts Recovery Assistance

In the past month, BOPA administered award payments to 87 grantees. Additional batches of award payments are currently in processing for disbursement. BOPA also fielded questions and provided pertinent information to grantees on grant reporting requirements.

Family League Economic Recovery Assistance

Family League secured a 97% response rate to the 6-month follow-up survey issued to child care providers that benefited from ARPA funds. Family League's engagement efforts in the distribution of ARPA funds included but are not limited to outreach to and sustained contact with child care providers (those who received grants and those that did not), attendance and participation at Child Care Coalition meetings, social media posts and a pre-proposal conference. Their engagement efforts were amplified through their successful partnership with: Baltimore City Child Care Resource Center, Baltimore City Child Care Coalition and the Maryland State Family Child Care Association. Each leveraged their trusted relationships with providers to help Family League engage the broadest community possible.

Baltimore City Recreation and Parks (BCRP)

BCRP was awarded \$41 million to modernize the City's recreation and park facilities, including pools, recreations centers, playgrounds, athletic courts, and trails. Since the last report, BCRP removed the Mary E. Rodman Recreation Center from its list of ARPA-funded projects, though an alternative funding source is being used for this project. The Greater Model pool has begun design while the Towanda and Coldstream pools are in design and are preparing to bid for construction. Design has begun for the Gardenville and Curtis Bay Recreation Centers, while BCRP is preparing the Parkview Recreation Center project to bid for construction. Finally, the Furley Recreation Center is also in design. The Recovery Office and BCRP have finalized performance measures for both construction monitoring and outcomes related to facility usage and satisfaction.

Baltimore City Health Department (BCHD)

To avoid a lapse in critical service provision, BCHD recently put a number of contracts that were previously fully funded by FEMA through emergency procurement to be funded by ARPA by 10% and by FEMA for 90% of costs, with the exception of food insecurity programs, which are

now 100% funded by ARPA. These included human service contracts for vaccination outreach and clinician support, contact tracing training, operational support, mobile testing vendors, and food insecurity provider and distribution contracts. BCHD is also in the process of preparing to move into the PPE warehouse, pending a Workday issue. BCHD is also making progress on recruiting for Baltimore Corps fellow positions for food insecurity and is setting up interviews for the grants compliance manager and analyst positions.

Mayor's Office of Children and Family Success (MOCFS)

The CASH Campaign continued its work to onboard pilot participants and prepare for the launch of the pilot. The project is on target to begin disbursing monthly payments to approved participants by the end of the summer.

Mayor's Office of Homeless Services (MOHS)

The Housing Navigation and Landlord Engagement project, a \$6.12 million effort to increase access to affordable housing units for low-income or no-income unhoused people, was approved to appear on the August 3, 2022, Board of Estimates agenda. The Recovery Office approved budgets for two additional projects: the Shelter Diversion and Rapid Resolution Fund and the Shelter Demobilization project. Corresponding applications are being reviewed and finalized.

MOHS is continuing conversations with the Department of Housing and Community Development (DHCD) about the Housing Accelerator Fund, its design and role within the broader affordable housing strategy. Once program design and Fund requirements have been finalized, the Recovery Office will work to execute a funding agreement with MOHS, authorizing four out of the five planned projects. City leaders are in active discussions about the fifth project, Shelter Acquisition, and the accompanying considerations typical for a large-scale capital project.

Broadband and Digital Equity

The Broadband and Digital Equity Office within BCIT continued the transition of this project from the Mayor's Office and began detailed planning for a new initiative as part of the Phase II Broadband investment. BDE is collaborating with BCRP to plan and execute the effort to extend City fiber to all recreation centers not currently on the City's network. This includes coordinating construction schedules since BCRP also received a substantial ARPA capital award related to recreation centers. BDE is also collaborating with the Housing Authority of Baltimore City (HABC) to complete a public Wi-Fi pilot at Gilmor Homes.

Mayor's Office of Neighborhood Safety and Engagement (MONSE)

Group Violence Reduction Strategy (GVRS): The new governance structure was fully tested, ensuring coordinated and effective deployment of the strategy. MONSE developed case management capacity for Coordinated Neighborhood Stabilization Response (CNSR), allowing the team to begin the process of logging relationships built and engagements made during the previous month's CNSR activations. In partnership with the Data team, the Community Engagement and Opportunity team evaluated the first CNSR responses in Howard Park and Rose Street. MONSE is also coordinating with the Mayor's Office through signed letters from Mayor Scott to inform residents of active CNSR anticipation in their community. The CNSR engagement strategy is rooted in identifying champions to aid in the stabilization of communities. CNSR identifies an active resident, business owner, community association, and church/faith-based organization (ABCCs) to serve as project managers or ABCCs for stabilization events. The ABCCs are most knowledgeable about community challenges and obstacles and are integral in working with government agencies and community partners for barrier removal.

Victim Services: MONSE, in partnership with BPD, hosted a community briefing at the University of Baltimore to share a preview of the Public Safety Partnership's Victims Assessment Report, which identifies prior gaps in the victim services landscape. This community briefing included hospital partners, direct service providers, and advocates. MONSE and BPD shared the work underway in victim services, supported in part by ARPA dollars, and outlined the shared workplan for the implementation process underway.

Data: Prototypes for Intimate Partner Violence (IPV) Stat and GVRS Stat have been developed and are being shared internally with partner agencies. An overview of IPV Stat was shared at the City Council Violence Against Women Hearing in the Health Committee in July.

Community Violence Intervention (CVI): MONSE welcomed a delegation from Atlanta's Office of Violence Prevention and Mayor's Office, who visited to learn about the work of the office, Baltimore's CVI ecosystem, and how the City is building a public health-based strategy for violence prevention and intervention.

Victim Services: ARPA funds are being utilized by the Intimate Partner Violence (IPV) initiative to offer offender accountability. MONSE has identified three IPV Community Based Organizations (CBOs) that offer Abuser Intervention and programs that are designed to help rehabilitate those who have repeatedly used violence towards their intimate partners and or family members. Through the work of CVI and the interconnectedness of the Health Alliance for Violence Intervention (HAVI) and school-based initiatives to IPV, MONSE is broadening the traditional ecosystem to include IPV related CBOs that include a focus on teen dating violence and offender focused work to place increased emphasis on both primary and secondary prevention as well as intervention strategies. MONSE is building connections between agencies to close existing gaps and optimize community resources.

Hiring: MONSE conducted a robust interview process for positions on the Victim Services and Data teams. As a result, offers were extended to MONSE's forthcoming Gun Violence Victim Services Manager and two Data Analysts. These hires will be joining the team between late August and early September.

Mayor's Office of Employment Development (MOED)

Train Up: All Train Up Occupational Skills Training providers have begun training, 7 funded by City ARPA and 11 funded by State ARPA. Two of three Community Connector contracts have been approved; the remaining BOE approval is expected to take place in August. A total of 201 participants enrolled in Occupational Skills Training, of whom 61 are in City ARPA-funded programs. A total of 65 enrollees have obtained certifications, 14 have completed training, and 7 have gained employment with an average wage of \$20.86 (includes City and State ARPA funded programs).

Hire Up: The Hire Up program is currently funded by a State RELIEF Act grant. Funding for the program will soon shift to City ARPA, likely in September 2022. As of July 31, 2022, 123 unemployed/underemployed Baltimore City residents have received subsidized employment through Hire Up. A total of 23 of those who remained in the program at least two weeks have transitioned to unsubsidized employment, 18 of whom reported an entry wage of \$15/hour or higher. Currently, MOED's worksites include: the Baltimore City Department of Transportation, Baltimore City Department of Finance, Baltimore City Recreation and Parks Department, Department of Public Works, Parking Authority of Baltimore City, Downtown Partnership of

Baltimore, and the Mayor's Office of African American Male Engagement, which also operates another worksite, The Food Project. MOED also serves as a worksite. There are currently 60 people employed with City Agencies, and there are 118 positions with City Agencies that have been identified for subsidized employment with Hire Up.

Workforce Supports: Hire Up and Train Up Project Managers are coordinating with two legal services providers, Maryland Legal Aid and Maryland Volunteer Lawyers Service, to integrate legal services. BOE approval is expected in August for the sub-agreement to provide behavioral health services for all Train Up and Hire Up participants. Implementation meetings took place in July and August to ensure services begin upon BOE approval.

In additional, through the Small Business Wage Subsidy, a total of 259 residents have been hired at small, minority and/or women-owned businesses. There have been 129 subsidies paid to businesses thus far (paid upon 10 weeks of employment): 61 of these are through City ARPA. City and State ARPA funding support a total of 205 subsidies.

YouthWorks: YouthWorks Summer Jobs placed 6,700 participants with employer worksites and run from July 5 through August 5, 2022.

Community Engagement: There are several tactics that MOED is using to communicate with and engage members of the community, including:

- Funding Community Connectors to further extend neighborhood reach;
- Promoting programs widely on social media channels and gathering feedback through those channels;
- Including MOED's ARPA offerings as a standing item on the agenda at Baltimore Workforce Development Board meetings, which are open to the public.
- Sharing information on MOED programs at Practice Advisory, the citywide networking body for workforce programs and supportive services.
- Designing participant satisfaction surveys as a further tool for gathering feedback.
- Promoting programs through MOED's full-service one-stop career centers, located in East and West Baltimore, as well as at Community Job Hubs, which support neighborhood organizations and provide neighborhood-based services by co-locating workforce services at community-based organizations.

Department of Housing and Community Development (DHCD)

DHCD's Impact Investment Area Neighborhood Relief Fund (IIANRF) was approved to appear on the August 3, 2022 Board of Estimates agenda. The project will provide critical funding for the acquisition of approximately 2,758 vacant homes, the stabilization of 100 vacant properties, provide 800 development incentives, and support 832 new and existing homeowners in DHCD's 7 Impact Investment Areas (IIAs). In the next month, the following items will be submitted for approval as necessary once project budgets are finalized:

- Uplands: Strategic Capital Investment
- Park Heights: Senior and Multi-Family Homeownership
- Tivoly: Strategic Capital Investment

In addition to DHCD's affordable housing initiatives, HABC will be leading the implementation of the following projects next month for approval:

• Perkins Somerset Oldtown Infrastructure (HABC): Strategic Capital Investment

• Perkins Somerset Oldtown Transformation Plan (HABC): Implementation of CHOICE Housing component

Department of Planning (DOP)

A key position for the SNAP Online program implementation has been approved and will be on the September 7, 2022, Board of Estimates agenda. DOP has begun the process of selecting retail partners to help increase participation.
